ANNUAL BUDGET PROCESS

Every year, the City Council conducts meetings on and publishes a tentative budget of revenues and expenses for the upcoming fiscal year. Our fiscal year begins on July 1st. The Fiscal Year 06-07 Tentative Budget will be presented to the City Council on May 9, 2006 for their approval as the document that will be subject to review by the public and the Council. After that time, the public may review the budget at the City offices or on the website.

The City Council will also conduct a public hearing on the Tentative Budget on June 13, 2006 at 7:00 p.m. at the City offices. At that time, the public is invited to submit comments to the Council regarding the budget. Comments or questions may also be submitted or raised prior to the hearing by contacting the City offices at any time.
