RESOLUTION NO. R21-52 (8-24-21)

**A RESOLUTION CANVASSING THE CITY OF
SARATOGA SPRINGS AUGUST 10, 2021 PRIMARY
ELECTION**

WHEREAS, the City of Saratoga Springs held a Primary Municipal Election on August 10, 2021; and,

WHEREAS, the City of Saratoga Springs contracted with Utah County to conduct the August 10, 2021 Primary Municipal Election; and,

WHEREAS, Section 20A-4-301(2), Utah Code Annotated, 1953, as amended states that the Mayor and City Council are the Municipal Board of Canvassers and shall canvass the election returns no sooner than seven days after the election and no later than 14 days after the election following a Primary Municipal Election.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SARATOGA SPRINGS, UTAH, ACTING AS THE BOARD OF MUNICIPAL CANVASSERS, THAT:

1. The attached final Election returns report as issued by Utah County Clerk/Auditor is hereby certified by the City Council of the City of Saratoga Springs, Utah, acting as the Board of Municipal Canvassers, as the official results for the 2021 Primary Municipal Election.
2. The City Recorder shall prepare and transmit a certificate of nomination under the City Recorder's seal to each nominated candidate, and publicize the certified report pursuant to Section 20A-4-304.

BE IT FURTHER RESOLVED that this resolution shall take effect immediately upon passage.
